**RE:** 2018-19 Tuition Equalization Grant (TEG) Final Allocation

This memo is to announce the enclosed 2018-19 final allocation amounts based on the appropriation from fiscal year 2019 for the TEG program.

On May 14, 2018, the 10-day allocation data review materials for the TEG program were issued to institutions. Institutions were invited to confirm that the "TEG Preliminary Allocation Calculation Data" accurately reflected the data submitted to the Texas Higher Education Coordinating Board (THECB). Institutions were allowed 10 days to review the data. That period ended at the close of business on May 29, 2018.

Through this process, THECB received no comments. Institutions participating in the TEG program will have the opportunity to submit a funds request form as early as **August 1, 2018** and payments for these requests will be processed after the first day of the new fiscal year, September 1, 2018.
